 - 1. Strategic Plan Review

- a. Draft revised based on feedback from admin and staff
 - i. Distributed to Board afternoon prior to this meeting
 - ii. Will be passed along to Admin and IC following the meeting (evening of November 20)

As of the end of October, we were 1/3 of the way through the school year and we've recognized 29% of expected revenue and 31% of total nonsurplus expenses. There were no edits to budget projections during the month from a cost standpoint, but we did see the first interest from the money market/Stifel accounts – October reflects \$2,345 of interest income. There are a few line items that reflect no YTD costs, such as health supplies and workers comp insurance, and I am in the process of verifying that the related expenses are being coded correctly. When we reach the halfway point of the year, I will work with the accountant to make sure that the working budget is refreshed with updated projections. I have no concerns to raise at this time.
